



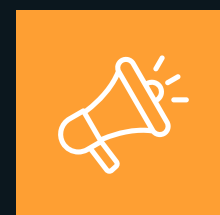

# Terms of use for the event



## *Cancellation & changes*

**We always offer a 14-day free cancellation period from the registration date.**

After this, the company can still cancel its participation by notifying in writing by 1.9.2026, but is still obliged to pay half (50%) of the price of the ordered fair package. If the company cancels its participation after 1.9.2026, the company is obliged to pay the price of the ordered fair package in full (100%).

## *Billing*

The order date is the date of sending the registration form. 50% of the price of the fair package will be invoiced as a booking fee for the ordered fair package on a separate invoice within 28 days from the order date or at the latest on the due date separately stated in the said invoice. The final invoice will be invoiced at the end of 2026 or in January 2027.

The payment term for all invoices is 14 days net, unless another payment term is agreed with the company. Additional orders placed after the first invoice has been sent will be invoiced after the order with the same payment terms.
